MESSAGE

NAVPHIL 078/20 – LUZON, S. COAST, MASBATE IS. – PORT PROTOCOLS

IN CONNECTION TO THE EFFORTS OF LOCAL GOVERNMENT UNITS TO CONTROL THE SPREAD OF COVID-19, THE FOLLOWING RULES ARE BEING IMPLEMENTED AT THE PORTS IN THE PROVINCE OF MASBATE FROM 23 MARCH 2020 AND WILL BE EFFECTIVE UNTIL FURTHER NOTICE:

I. RESTRICTIONS TO MOVEMENT OF PEOPLE

- A. ENTRY OF PERSONS TO THE PROVINCE OF MASBATE, WHICH INCLUDES THE ISLANDS OF TICAO AND BURIAS, IS PROHIBITED.**
- B. MOVEMENT OF PEOPLE BETWEEN THE ISLANDS OF MASBATE, BURIAS, AND TICAO IS PROHIBITED EXCEPT FOR THOSE PURCHASING BASIC GOODS OR REQUIRING MEDICAL ASSISTANCE. PERSONS COMING TO MASBATE ISLAND FROM THE ISLANDS OF TICAO AND BURIAS MAY ONLY DISEMBARK AT THE PORTS OF AROROY AND MASBATE CITY.**
- C. NO CREW ARE ALLOWED TO DISEMBARK FROM THEIR VESSEL AT ANY POINT IN MASBATE PROVINCE.**

II. RESTRICTIONS TO MOVEMENT OF CARGO

- A. NO CARGO SHALL BE TRANSPORTED TO ANY ISLAND OF MASBATE PROVINCE EXCEPT FOR BASIC FOOD PRODUCTS, ESSENTIAL AND HYGIENE PRODUCTS, HEALTH AND MEDICAL PRODUCTS, GAS, FUEL, LUBRICANTS, AND CASH. SUCH CARGO MAY ONLY BE UNLOADED AT THE FOLLOWING PORTS:**
 - 1. PORT OF THE CITY OF MASBATE**
 - 2. PORT OF SAN JACINTO, TICAO ISLAND**
 - 3. PORT OF SAN PASCUAL, BURIAS ISLAND**
 - 4. PORT OF AROROY, MASBATE ISLAND**

5. PORT OF CATAINGAN, MASBATE ISLAND
6. OTHER PRIVATE PORTS IN THE PROVINCE ACCREDITED BY THE PHILIPPINE PORTS AUTHORITY (PPA)

MASTERS OF VESSELS WISHING TO CALL AT ANY PORT IN MASBATE PROVINCE ARE ADVISED TO CONTACT THE PORT AUTHORITIES FOR FURTHER GUIDANCE.
