INVITATION TO BID

PROCUREMENT OF FOUR (4) OUTBOARD MOTORS

The National Mapping and Resource Information Authority (NAMRIA), through the *General Appropriations Act 2016* intends to apply the sum of ONE MILLION THREE HUNDRED NINETY-TWO THOUSAND PESOS ONLY (**PhP 1,392,000.00**) being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of Four (4) Outboard Motors**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

NAMRIA now invites bids for the **Procurement of Four (4) Outboard Motors**.¹ Delivery of goods is required for the C.Y. 2016. Bidders should have completed, within five (5) years (April 2011 to March 2016) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from NAMRIA and inspect the Bidding Documents at the address given below during office hours.

A complete set of Bidding Documents may be **acquired** by interested Bidders on _____ from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ONE THOUSAND FIVE HUNDRED PESOS ONLY (PhP 1,500.00).

¹ A brief description of the type(s) of Goods should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

6. Bids must be delivered to the address below on or before _____. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
