## MESSAGE

### **NAVPHIL 060/20 – VISAYAS ISLANDS, SAMAR IS. – PORT PROTOCOLS**

**IN CONNECTION TO THE EFFORTS OF LOCAL GOVERNMENT UNITS TO CONTROL THE SPREAD OF COVID-19, THE FOLLOWING RULES ARE BEING IMPLEMENTED AT THE PORTS IN THE PROVINCES IN SAMAR ISLAND:**

#### **I. RESTRICTIONS TO MOVEMENT OF PEOPLE**

**A. ENTRY OF PERSONS TO RESPECTIVE PROVINCES AND CITIES IN SAMAR ISLAND ARE PROHIBITED EXCEPT HEALTH WORKERS, AUTHORIZED GOVERNMENT OFFICIALS, PERSONS WHO ARE TRAVELING DUE TO MEDICAL AND HUMANITARIAN REASONS, AND OTHER PERSONS AUTHORIZED BY LAW. THE FOLLOWING ARE THE DURATION OF SAID PROHIBITIONS FOR EACH PROVINCES:**

- 1. EASTERN SAMAR PROVINCE: 22 MARCH TO 12 APRIL 2020**
- 2. NORTHERN SAMAR PROVINCE: 19 MARCH TO 15 APRIL 2020**
- 3. SAMAR PROVINCE: 19 MARCH TO 15 APRIL 2020**

**B. ALL MOTORBOATS, BANCAS, AND SIMILAR VESSELS COMING FROM AREAS OUTSIDE OF SAMAR PROVINCE ARE NOT ALLOWED TO DOCK OR LAND AT ANY BARANGAY OF THE PROVINCE FROM 19 MARCH TO 15 APRIL 2020.**

**C. VESSELS ANY KIND FROM AREAS OUTSIDE OF EASTERN SAMAR PROVINCE ARE NOT ALLOWED TO DOCK OR LAND AT THE COASTLINE OF THE PROVINCE FROM 22 MARCH TO 12 APRIL 2020.**

#### **II. RESTRICTIONS TO MOVEMENT OF CARGO**

**A. VESSELS ARE ALLOWED TO UNLOAD AND LOAD CARGO AT ANY PORT IN SAMAR ISLAND. HOWEVER, CREW MEMBERS OF SAID VESSELS AND DELIVERY PERSONNEL WILL BE SUBJECTED TO APPLICABLE HEALTH AND QUARANTINE PROTOCOLS.**

**MASTERS OF VESSELS WISHING TO CALL AT ANY PORT IN SAMAR ISLAND  
ARE ADVISED TO CONTACT THE PORT AUTHORITIES FOR FURTHER  
GUIDANCE.**
