MESSAGE

NAVPHIL 068/20 – PHILIPPINES, CENTRAL PART, MINDORO IS. – PORT PROTOCOLS

IN CONNECTION TO THE EFFORTS OF LOCAL GOVERNMENT UNITS TO CONTROL THE SPREAD OF COVID-19, THE FOLLOWING RULES ARE BEING IMPLEMENTED AT THE PORTS IN THE PROVINCES IN MINDORO ISLAND:

- A. ENTRY OF PERSONS TO OCCIDENTAL MINDORO PROVINCE, INCLUDING LUBANG ISLAND, IS PROHIBITED FROM 15 MARCH 2020 UNTIL FURTHER NOTICE.**
- B. ENTRY OF PERSONS TO ORIENTAL MINDORO PROVINCE IS PROHIBITED FROM 14 MARCH TO 13 APRIL 2020.**
- C. HEALTH WORKERS, AUTHORIZED GOVERNMENT OFFICIALS, PERSONS WHO ARE TRAVELING DUE TO MEDICAL AND HUMANITARIAN REASONS, AND OTHER PERSONS AUTHORIZED BY LAW ARE EXCLUDED FROM THE ABOVE-MENTIONED TRAVEL RESTRICTIONS. HOWEVER, SAID PERSONS WILL BE SUBJECTED TO APPLICABLE HEALTH AND QUARANTINE PROTOCOLS.**
- D. VESSELS ARE ALLOWED TO UNLOAD AND LOAD CARGO AT ANY PORT IN MINDORO ISLAND. HOWEVER, CREW MEMBERS OF SAID VESSELS AND DELIVERY PERSONNEL WILL BE SUBJECTED TO APPLICABLE HEALTH AND QUARANTINE PROTOCOLS.**

MASTERS OF VESSELS WISHING TO CALL AT ANY PORT IN SULU ARCHIPELAGO ARE ADVISED TO CONTACT THE PORT AUTHORITIES FOR FURTHER GUIDANCE.
